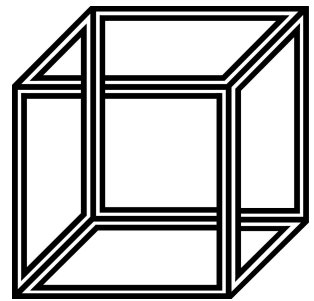

### **Section III: Terms of Service**

1. Echoes will provide 4 hours of entertainment plus no more than 1 hour of complimentary dinner music, an extensive music library, 2 deejays, emcee services, 2 wireless microphones, light show, liability insurance, and unlimited consultations by phone or email.
2. The fee for 4 hours of music entertainment is \$450.00. The fee for entertainment over 4 hours is \$50.00 per hour, pro-rated for fractions of an hour. \$50.00 will be deducted for Friday, non-holiday dates. \$100.00 will be deducted for any event on a Sunday through Thursday, non-holiday date. \$50.00 will be deducted if client declines the light show. A non refundable deposit of \$100.00, payable toward the total fee, is required upon execution of this Contract. The entire Contract balance payable to Echoes Sound & Light, Inc., must be paid by the beginning of the event. A \$50.00 rescheduling fee will be charged if the event must be rescheduled and such is possible.
3. Echoes retains the right to substitute deejays if necessary due to illness, accident, unavailability, act of God, or other reason.
4. Client agrees to furnish, at client's own expense, electricity, a meal for each deejay (if a meal is provided to guests) and parking. Client also agrees to provide, at its expense, the following: One 6' to 8' table, a 12' x 10' area for set up (6' x 8' with no lights) no more than 45' from a reliable power source (2, 15 amp., 110 volt circuits), access to area 90 minutes prior to event for set up, access to area 45 minutes after event for take down, cover from elements (i.e. rain) for deejays and equipment, notification as soon as possible in case of cancellation, and a safe environment for the deejays and equipment.
5. It is understood that Echoes executes this agreement as an independent contractor and not as an employee, and that Echoes shall have exclusive control over the performance date(s), performance time(s), and length of show(s).
6. If engagement is not presented due to circumstances not under the control of Echoes including but not limited to client canceling or postponing event; bad weather, rain, snow, high winds; or any other reasons, and Echoes is ready, willing and able to perform, Echoes shall be paid in full.
7. Echoes assumes no liability with this engagement or liabilities caused by failure of a deejay to appear to perform except, however, should a deejay fail to appear for any reason other than Client canceling event, Echoes agrees to return to client any fees paid to Echoes for this engagement.
8. Client agrees to pay any and all costs of collection in the event of client's default under this contract, including reasonable attorney fees.
9. Echoes agrees to pay to client the sum of \$5 for every minute that the deejay is late in beginning the show as a result of actions on the part of Echoes.
10. Client is liable for damages to Echoes's property sustained as a result of guests' actions.
11. Echoes is not responsible for the actions of client's guests and client shall hold Echoes and its employees harmless for any damages or injuries resulting there from.
12. This instrument constitutes the entire agreement between both parties, and no statement, promise or inducement by any party hereto, which is not contained herein, shall be binding or valid, and this agreement may not be enlarged, modified or altered, except in writing by both parties hereto.
